Reno De Medici S.p.A.: update on implementation of buyback execution

PURCHASES IN THE PERIOD FROM 3 DECEMBER – 7 DECEMBER 2018

Milan, 10 December 2018 - Reno De Medici S.p.A. announces that, during the period from 3 December – 7 December, has purchased 500,974 of its own ordinary shares on the Mercato Telematico Azionario (Italian Equities Market), equal to 0.133% of the share capital, at an average price per share of €0.705 for an aggregate amount of €353,342.81.

The purchases were made following the authorisation deliberated by the Ordinary Shareholders' Meeting on 30 April 2018 and in execution of the buy-back programme already discussed in the public announcement on 31 October 2018.

Below is reported the overall summary on a daily basis of the purchases made in the period indicated, on the basis of the information provided by the appointed intermediary:
