INTEGRATION AND RECTIFICATION OF THE ORDINARY SHAREHOLDERS' MEETING'S NOTICE OF CALL

As integration and rectification of the notice of call published on March 19th, 2020 with which has been convened for April 29th, 2020, at 10.00 am, on first call, and if necessary, on April 30th, at same time, on second call, the Ordinary Shareholders' Meeting of Reno De Medici S.p.A., in Milan, at the Italian Stock Exchange registered office, Piazza degli Affari n. 6 (the "**Shareholders' Meeting**"), following the entry into force of Law Decree No. 18/2020 (the "**Decree**") - which introduced some exceptional rules, due to COVID-19 emergency, applicable to the shareholders' meetings of listed companies - and following the entry into force of the Prime Minister Decree of March 22nd, 2020, effective from March 23rd, 2020, which provided the "ban to all individuals to move, by public or private means of transport, to a different municipality than the one in which [on that date] they are located" (the "**PMD**") Reno De Medici S.p.A. proceeds with the integration and rectification of the aforementioned notice of call as follows.

In order to minimize the risks associated with the ongoing health emergency, the Company has decided:

- to make use of the faculty - established by the Decree - to provide in the notice of call that legitimacy for the participation of the shareholders to the Shareholders' Meeting and the exercise of the right to vote occur exclusively through a representative designated pursuant to Article 135-undecies of Legislative Decree No. 58/98 ("**TUF**"), without physical participation of the shareholders themselves;
- that the participation of the directors, of the statutory auditors, of the designated representative, of the secretary of the meeting and of the representatives of the auditing company, if intervened, will take place in compliance with the containment measures required by law, and therefore exclusively through electronic means of communication that allow immediate identification and participation, with connection methods that will be communicated by the Company to the interested parties, without, in any case, the need for the President and the Secretary to be in the same place; and
- in consideration of the above, to provide that the Shareholders' Meeting will be held at the Zabban - Notari - Rampolla & Associati Firm, in Milan, Via Metastasio n. 5.

The text of the notice of call is reported below, as well as integrated and rectified, by underlining the integrated and rectified parts and with strikethrough text for the deleted words.

- a) the share capital, at the date of publication of this notice of call, is equal to Euro 140,000,000, divided into 377,800,994 shares, broken down as follows:
 - 1) 377,546,253 ordinary shares;
 - 2) 254,741 savings shares convertible into ordinary shares which, pursuant to Article 6 of the Company By-Laws, do not carry the right to vote at ordinary or extraordinary shareholders' meetings;
- b) each ordinary share gives the right to one vote at Shareholders' Meetings;
- c) the Company holds 2,262,857 ordinary treasury shares, equal to 0.599% of the share capital.

ENTITLEMENT TO PARTICIPATE AND EXERCISE VOTING RIGHTS. DESIGNATED REPRESENTATIVE.

It should be noted that due to the emergency of Covid-19, and therefore in compliance with fundamental principles of protection of the health of the shareholders, employees, representatives, and consultants of the Company, as well as, lastly, the Decree and the PMD, the Shareholders' Meeting will take place with the participation in the Shareholder's Meeting, for the persons admitted, exclusively through telecommunication means and that the share capital will be able to intervene exclusively through the Designated Representative pursuant to article 135-undecies of Legislative Decree No. 58 of 24 February 1998 ("TUF") in the manner described below, by excluding the access to the meeting rooms.

The shareholders with voting rights have the right to participate at the Shareholders' Meeting - **exclusively through the Designated Representative** - in accordance with the regulatory framework in force. In this regard, pursuant to Article 83-sexies of Legislative Decree No. 58 of February 24, 1998, the entitlement to participate in the Shareholders' Meeting and to exercise the voting rights is certified by a communication to the Company, made by an authorized intermediary under the applicable rules, in accordance with its accounting records, in favor of the person holding the voting right, based on the evidence at the end of the seventh trading day preceding the date of the Shareholders' Meeting on first call (i.e. April 20th, 2020). Those who become owners of the Company's shares after that date are not entitled to participate and vote at the Shareholders' Meeting. The communication from the intermediary should be delivered to the Company within the end of the third trading day preceding the date of the Shareholders' Meeting on first call (i.e. April 24, 2020). This is without prejudice to the entitlement to participate and exercise the voting rights (**exclusively through the Designated Representative**) if the communications are received by the Company after that deadline, provided that they are received within the start of the Shareholders' Meeting on first call.

APPOINTMENT OF THE BOARD OF DIRECTORS

The Board of Directors is appointed in accordance with the terms and provisions of Article 12 of the Company's By-Laws, to which reference is made, **without prejudice to the application of mandatory rules.** It should be reminded that, pursuant to the aforementioned Article 12 of the By-Laws, the Board of Directors is made up of a minimum of 5 to a maximum of 15 Directors and that, before proceeding with their appointment, the Shareholders' Meeting is called upon to determine their duration and the number of the members.

The Board of Directors will be appointed on the basis of lists presented by the shareholders in which the candidates must be listed with a progressive number, according to the procedures indicated below.

provided for by the regulations in force at that time. The lists will remain deposited at the Company's registered office and will be available to anyone who requests them.

Only those shareholders who, alone or together with other presenting Shareholders, hold shares representing at least 2.5% of the share capital with voting rights in the Ordinary Shareholders' Meeting are entitled to submit lists, pursuant to Consob regulation no. 28 of January 30, 2020.

Along with each list, within the related terms indicated above, the following documents must be filed: (i) the declarations with which the individual candidates accept their candidacy and certify, under their own responsibility, the non-existence of causes of ineligibility and incompatibility provided by the law and by the By-laws, as well as the existence of the requirements provided for the respective offices; (ii) a curriculum vitae concerning the personal and professional characteristics of each candidate with the possible indication of their suitability to qualify as independent pursuant to Article 148, paragraph 3, of Legislative Decree 58/1998.

The appropriate certification issued by an intermediary authorized by law proving the ownership of the number of shares needed for the presentation of the list, at the time of filing the list with the Company, must also be filed within the term provided by the applicable regulations for the publication of the lists by the Company.

Each shareholder, the shareholders who adhere to a significant shareholders agreement pursuant to Article 122 of the Legislative Decree 58/1998, the controlling entity, the subsidiaries and those subject to common control pursuant to article 93 of Legislative Decree 58/1998, cannot present or participate in the presentation, not even through a third party or trust company, of more than one list, nor can they vote for different lists and each candidate may appear only on one list under penalty of ineligibility. Any endorsements and votes casted in violation of this prohibition shall not be attributed to any list.

The lists presented without observing the above-mentioned provisions are considered as not presented.

Those who intend to submit the lists for the appointment of the Board of Directors are invited to observe the recommendations provided for by Consob with Communication No. 9017893 of February 26, 2009, which invite the shareholders who present a minority list to file, along with the list, a declaration certifying the absence of any liaison relationships, including indirect ones, pursuant to art. 114-quinquies of Consob Regulation No. 19971/1999.

For the procedures of appointment of the Board of Directors, please refer to the provisions of the aforementioned Article 12 of the Company's By-Laws which can be consulted on the Company's website (Governance/By-laws), **without prejudice to the application of mandatory rules.**

It should also be remembered that the appointment of the Board of Directors will take place in compliance with the applicable *pro tempore* regulation on gender balance. Therefore, pursuant to Article 147-ter, paragraph 1-ter, of Legislative Decree 58/1998, the lists presenting a number of candidates equal to or greater than three must include candidates of the less represented gender in order to guarantee that the new Board of Directors is composed, at least for two fifths, by Directors of the less represented gender, with rounding, in case of fractional number, to the higher unit.
